

# OFFICIAL NEC CORPORATION OF AMERICA FTE 2023 SWEEPSTAKES RULES

## NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR TO WIN

The NEC Corporation of America ("NEC" or "Sponsor") FTE 2023 Sweepstakes ("Sweepstakes") is sponsored by NEC Corporation of America, 3929 W. John Carpenter Freeway, Irving, TX 75063.
